### **International Propeller Club of Norway**

## **Code of Conduct**

#### 1. Purpose

The purpose of this Code of Conduct is to establish standards of integrity, ethical behavior, and accountability for all members of the International Propeller Club of Norway: Ports of Oslo (the "Club"), including but not limited to board members, committee members, honorary members and members. This Code aims to foster a culture of transparency, trust, and professionalism in all activities of the Club.

## 2. Scope

This Code applies to all members, including board members, officers, committee members, and others. It outlines the principles and expectations for conduct, including but not limited to integrity, conflict of interest, confidentiality, and accountability.
